IN THE BEGINNING! HISTORY OF W.S.W.T.A. PART I.

(Taken from the Evergreen State Clarion, November 1950 – June 1951. I believe it was summarized by Wallace Marshall, Clarion Editor)

An evolutionary pattern proceeds from the general to the specific. W.S.M.T. A. evolved in similar fashion. Its parent organization, the Northwest Music Teachers Association, was founded in Seattle in the year 1908 and aimed to promote "the advancement of musical knowledge and education in the Pacific Northwest states." The states included were Washington, Oregon, Idaho and Montana. After the first year Montana withdrew because there was logical expectation that annual conventions would be held on or near the coast. Distances in those years were not easily and inexpensively encompassed, and hence comparatively few members had been recruited in the State of Montana.

All music teachers were eligible to membership and dues were \$2.00 a year. The Association's official bulletin, called the NORTHWEST QUARTERLY MUSICAL REVIEW, was identified with the weekly TOWN CRIER, published every Saturday in Seattle. That bulletin, first so published in the December 19, 1914 issue of the TOWN CRIER, was edited by Mrs. Helen Howarth Lemmel and contributions from each member state were given equal coverage, but only two editions of the bulletin appeared.

For seven years the Northwest Association functioned as an entity, convened each year but one and was guided by the following pioneer members of the music teaching profession:

1908 - Lucy K. Cole (Seattle)

1909 - Edmund J. Myer (Seattle)

1910 - Walter G. Reynolds (Seattle)

1911 - Clifford W. Kantner (Seattle)

1912 - Elias Blum (Walla Walla)

1913 - W. H. Boyer (Portland)

1914 - Edgar Fischer (Walla Walla)

1915 - Lucy K. Cole (Seattle)

1915 - balance of year, George H. Street (Portland)

By 1915 it was realized that the geographical area embraced was too large for adequate coverage. Lucy K. Cole, Supervisor of Music in the Seattle Public Schools and President of the Association, stated:

If music would be in line with the great upward march of all forms of civic and social betterment, she must do as the others do, work strenuously through organized effort for the common cause. There is much to be accomplished for music in the Northwest, and, if our present form of organization is not adequate to meet the needs of the situation, we must change our plan of oganization.

Prior to meeting at the convention in Tacoma in 1915, she stressed the need for State Music Teachers Associations, with chapters in each county and large cities throughout each State. Such state organizations, she argued would promote closer relationships and more general interchange of ideas among musicians. would keep a larger body of people actively at work for the musical interests of the State. She recommended that serious consideration be given to such reorganization at the forthcoming convention and, furthermore, that the matter of high school credit for private music study also be discussed.

The (Northwest) Association met in Tacoma, June 16 to 19, 1915 as planned and Miss Cole's recommendation for reorganization appealed to the membership. However, the Northwest Association was not officially dissolved at this time. George Hotchkiss Street of Portland was elected to the presidency, and the next annual meeting was scheduled for Summer 1916 in North Yakima. In December 1915 the Executive Board decided to suspend further meetings to see if the trend toward state organization would prove successful. The Northwest Association as such never re-assembled.

On June 19, 1915, immediately following adjournment of the Northwest convention in Tacoma, the Washington State Music Teachers Association was organized. In the words of its founders, "this Association is for the certification of the teacher and has for its special object the standardization of music in the schools throughout the State. County organizations will follow, and it is hoped that eventually a Pacific Coast organization will be made possible."

Edtl, and Fritz Kloepper, all of Tacoma; Mrs. J.T. Hedges, Mrs. C. K. Lee and Pearl L. Buser (North Yakima); and Elias Blum (Walla Walla), Myra R. Wylie (Cheney), Herbert Kimbrough (Pullman), Edgar C. Sherwood (Spokane), Jessie Belton (Puyallup), and Anna E. Stewart (Everett).

It would be wonderful to have 100% participation. Perhaps afterwards, the main events of all chapters can be combined and added to our state archives to keep for the future. This would also give each chapter an historical compilation to take home and keep in their own archives.

# STUDENT STUDY GRANT PROGRAM

## Call for Student Study Grant Applications

Established twelve years ago with a bequest from the Lois Whitner estate, the **WSMTA Student Study Grant** program will be accepting requests for applications for the 2015-2016 year. The purpose of the program is to provide financial assistance for continued private study to music students who demonstrate financial need and who show serious commitment to music study. The following guidelines apply:

- 1. The grant is open to music students **currently in grades 8 11** who have studied a minimum of 4 years and whose teachers are members (of at least 12 months standing) of WSMTA.
- 2. The applicant will be considered on a basis of financial need and commitment to music study.
- 3. The applicant must have participated in WSMTA sponsored adjudications.
- 4. Grants up to \$1,500 may be awarded. The applicant must explain specifically and in detail how the funds will be used. The grant will be for a period of not more than one year. Students may reapply in subsequent years by submitting another full application to the committee for consideration.
- 5. The grant may be used to offset the cost of music lessons, theory, or composition classes, or tuition for music camps.
- 6. The grant will be sent directly to the teacher or camp/program director.

# **Enrichment**



Many of us are looking for ways to increase our studio enrollment, especially during the morning and early afternoon times. One viable option is teaching home-schooled students; other option is teaching adult students, especially adult beginners in a Recreational Music Making environment. This Recreational Music Making movement has been featured in many MTNA and even WSMTA conferences over the past In fact, MTNA now offers a Teaching Specialist program: "The MTNA Specialist Program provides music teachers an opportunity to obtain a designation as a teaching specialist in the areas of RMM (Recreational Music Making) and/or Group Piano. The Specialist designation demonstrates to the public, employers, and peers that a teacher has devoted special attention to a particular teaching approach and has demonstrated specific understanding of the teaching approach to obtain the designation. Upon completion of requirements, applicants are granted the designation MTNA RMM Specialist or MTNA Group Teaching Specialist."

One of the prominent musicians to develop RMM materials is Debra L. Perez who has promoted and written new music for this learning style. If you are interested in adding this teaching dimension to your studio, I encourage you to visit <a href="https://www.musicalMomentsRMM.com">www. MusicalMomentsRMM.com</a> to view the materials she has co-written with Will Baily.

Musical Moments includes Student Books 1-3 with Teacher's Manuals for each level, Reflective Moments Books 1-3. Christmas Moments and Sacred Moments. All student books come with CD's. The website includes excerpts from each of the books. The books are designed to be used in preferably group but also private learning environments. The student books have very clear and simple pages with no extraneous instructions. Two pages are devoted to playing on black keys, and then two pages to prestaff notation, followed by grand staff introduction. C major hand position is utilized and letter names are written in the note heads for the first few pieces. A

simple left hand accompaniment is introduced immediately.

The point of these materials is to encourage enjoyable keyboard learning so that the students are playing music right from the start. The CD's provide wonderful background accompaniments and there are teacher accompaniments as In her foreword Debra Perez well. quotes Karl Bruhn and Barry Bittman, the forefathers of the Making Music and Wellness movement: "Recreational Music Making refers to any form of music making that is not based on mastery of performance. It encompasses enjoyable, accessible and fulfilling group or individual music-based activities that unite people of all ages..."

Another series by these same authors is "Way Cool" Keyboarding and "Way Cool" Keyboarding 4 Kids" for the younger generations. These books provide music in contemporary, rock' n roll, praise and worship, and pop styles. The CD accompaniments are exceptional for young students. One can't help but feel the beat! There are 11 "Way Cool" chord chards that span the two book series, and creative "off the page" musical experiences. If you want to try working with chord charts and improvisation in your studio, take a look at these books.

If Recreational Music Making is of interest to you, be sure to attend the MTNA National conference in Las Vegas, March 21-25, 2015. Pedagogy Saturday features an entire day on Recreational Music Making.


